Duties and Responsibilities:

- Lead and oversee planning, implementation and M&E of PMTCT and EID program and services under the USAID Boresha Afya Southern Zone Program, in her/his respective council(s).
- Lad implementation of key program initiatives in her/his unit to address program, donor and national priorities such as index HIV testing, Option B+, male involvement, tracking of mother-infant pairs, follow-up of EID results in line with national guidelines.
- Provide TA to the R/CHMT and HFs in planning, implementation, M&E and reporting of PMTCT and EID services.
- Work with R/CHMT to ensure that supported facilities implement integrated and comprehensive package of PMTCT and EID services at all levels through:
 - o Participation in supportive supervision with R/CHMTs
 - Participate in capacity building and implementation of the national guidelines and tools for PMTCT and EID services
 - o Be responsible with the achievement of program targets for PMTCT and EID services
 - Strengthen systems for M&E of PMTCT and EID (paper tool and/or software) and ensure their availability and proper use at all supported facilities
- Support the capacity building activities in collaboration with R/CHMTs to identify training/mentorship needs at the supported facilities and organize trainings/mentorship program for facilities level staff using currently recommended national curriculums.
- Identify, conduct capacity building and effectively engage key community resource persons-including CSOs, mother peers-to accelerate tracking of missing mother-infant pairs.
